1. **Definitions** - In these terms and conditions, the following definitions apply:
 - 1.1. **“you” or “your”** means a member of SAGHS or a person applying for membership or renewal of membership of SAGHS;
 - 1.2. **“SAGHS”** means the South Australian Genealogy & Heraldry Society Inc.
2. **Your undertakings** – You undertake and agree that at all times you will:
 - 2.1. comply with the Constitution of SAGHS;
 - 2.2. not engage in any conduct which is contrary to the objectives of SAGHS or which might damage the reputation of SAGHS or its officers, employees, volunteers or agents;

CODE OF CONDUCT

Introduction
